# Piedmont Nickel-Cobalt Project Option Agreement Update

Alligator Energy Limited **ASX:AGE** (**Alligator** or the **Company**) refers to the ASX announcement dated 8 February 2022 where it advised that it had secured a twelve-month option to acquire a 100% interest in the Exploration Licences that form the Piedmont Farm-in and Joint Venture with Chris Reindler and Partners.

Highlights of the 8 February 2022 announcement included:

- Alligator has secured a binding twelve-month option to acquire 100% interest in the remaining Exploration Licences at the Piedmont Project, Northern Italy that it doesn't already own, and
- The twelve-month option is conditional on obtaining renewal of the Laghetto Exploration Licence and translating the Binding Term Sheet into a full form agreement.

Alligator is now pleased to provide the following update on the status of finalising the conditions precedent to the option becoming effective, namely:

- Confirmation of renewal of the Laghetto Exploration Licence has been obtained for the period through to 31 December 2023; and
- The Binding Term Sheet has been translated into a full form agreement and is with the Company's Italian legal counsel for review and confirmation of compliance with local regulatory requirements.

The Parties have agreed to a 30-day extension through to 7 May 2022 for the purpose of finalising the outstanding condition precedent.

#### Status of planning for the geophysics program at the Piedmont Project

A field trip by Alligator's in-country team to map and sample recently accessible lower altitude sites at the Isola prospect and undertake further reconnaissance for proposed geophysics is scheduled to commence from the 8 April 2022. In addition to sampling at the Isola prospect, the team will investigate the Cruvino prospect for the first time, where historic records have indicated high-grade, dyke-associated cobalt occurrences.

Contractors are currently being engaged to undertake ground-based EM geophysics at Alpe Laghetto and broader ranging drone magnetic surveys over additional prospects. Final planning and logistics are now underway with surveys targeted to commence early Q3.
