The company has a US\$7.5 million debt facility (US\$5.71 million loan availability) with Macquarie Bank Limited which matures in September 2024. The facility is supported by its gas production assets in the Appalachia region of the USA and carries an interest rate of US LIBOR+650bps. Empire made a US\$137,500 debt repayment during the Quarter reducing the outstanding balance from US\$5,987,510 to US\$5,712,510.

Answer: Cash outflows from investing activities were elevated for the Quarter as Empire settled Carpentaria-2H drilling costs and ordered long-lead items for the forthcoming Carpentaria-2H fracture stimulation.

Empire's cash balance at the end of the March 2022 represented ~65 times net cash used in operating activities for the March 2022 Quarter, reflecting ample liquidity to continue to fund operating activities.

After the end of the Quarter, AusIndustry informed Empire that it had approved the first progress payments under the *Beetaloo Cooperative Drilling Program* grants which will increase Empire's cash balance by \$2.9 million when received.
