Takeover Offer Update

Tamawood Limited (ASX: TWD) (**Tamawood**) refers to its bidder's statement dated 6 April in respect of its all scrip takeover offer for 100% of the fully paid shares in AstiVita Limited (ASX: AIR) (**AstiVita**) (Takeover Offer).

Tamawood as at the date of this announcement have voting power in AstiVita of 5.94%.

Tamawood has lodged a notice of initial substantial holder (Form 603) and as required, each time that Tamawood voting power as a substantial holder changes by 1% or more, Tamawood will lodge a Notice of change of interest of substantial holder (Form 604) in relation to its Takeover Offer.
