Fund commentary

The Janus Henderson Global Sustainable Equity Active ETF (Managed Fund) (ASX: FUTR) (Fund) returned -4.51% net of fees in April, compared with -3.11% from the MSCI World Index (net dividends reinvested) in AUD (Benchmark).

No exposure to Amazon, Alphabet and Netflix was beneficial to the Fund's relative performance. However, the Fund's overweight allocation to the information technology sector hurt returns.

The Fund's leading stock contributors over the month were the energy utility provider SSE, health insurance company Humana, and customer relationship software provider Zendesk.

There was a positive response to the news that SSE was acquiring a wind development portfolio from Siemens Gamesa. This incorporates Spain, France, Italy and Greece, and enables SSE to expand beyond the UK. The shares have performed well so far this year because of energy price increases and government intentions to increase energy independence with cleaner alternatives. SSE is also moving towards renewable energy. The company is focused on electricity generation and regulated transmission networks, and is playing a critical role in enabling the UK's transition to a low-carbon economy. The company is the largest developer of renewable energy projects in the UK and has a target to treble its clean energy output by 2030.

Humana reported earnings that were ahead of expectations and raised its earnings guidance, given better-than-expected results in the mail-order pharmacy business together with lower administrative expenses. The company expects robust membership growth for 2022, and its Chief Executive, Bruce Broussard, also envisages strong progress towards improving membership growth in 2023. Humana is selling its investment in hospices and using the proceeds to reduce debt. Humana's focus is on providing health insurance to senior citizens in the US. It is a pioneer in integrated care, with the aim of reducing costs for its members, through better prevention of health problems and programmes to encourage healthier lifestyles. It has a range of clinical capabilities and is meeting the growth in demand for retirees' healthcare by offering affordable products. We see the company as a beneficiary of growth in the ageing population, and we like its ability to drive better outcomes.

Zendesk's shares jumped, following reports that the company had appointed an adviser to help explore a potential sale. It also reported a year-on-year rise in revenue of 30%, which was in line with estimates. Higher-spending customers now represent a growing share of the business. Zendesk's aim is to help organisations build better relationships with their customers. Its software simplifies the process of providing customer access across various channels. The shares have performed better than those of its software peers over recent months, boosted by the failed acquisition of Momentive, and have now been given further momentum by a possible sale of the company.

The largest detractors were computer chip manufacturer, Nvidia, and project management software developer, Atlassian, two of our information technology companies. Our holding in bicycle part manufacturer, Shimano, also detracted from returns.

There was no significant news on Nvidia. The fall in the share price followed similar moves among its semiconductor peers. Negative influences in the sector included supply chain issues, fears of slowing consumer demand, and the possible impact from Russia/Ukraine tensions. Nvidia remains an essential company in facilitating access to advanced computing in a way that benefits society and there has been no change in our long-term investment thesis.

Atlassian's share price fall came despite strong earnings, which were ahead of estimates. There were bullish comments from its management on prevailing demand, although disappointing guidance for the next quarter, as well as being caught up in the general sell-off among technology companies, caused the share price to fall. We remain positive on the longer-term prospects for Atlassian. It creates software that helps to increase productivity and its development is well-placed to accelerate as it transitions to a cloud-based model. We believe it could be one of the most important companies in terms of its impact on society.

The Fund's leading stock contributors over the month were the energy utility provider SSE, health insurance company Humana, and customer relationship software provider Zendesk.

Finally, Shimano's share price fall could be attributed to comments from the company suggesting that the pandemic-driven bike boom is slowing. Nevertheless, results were strong for the first quarter and demand remained strong in some areas. In addition, its management announced a share buyback. Shimano is a leading global manufacturer of bicycle components and our conviction in the company remains high. The company is renowned for its high-quality craftsmanship and has a long history of developing original technology and innovative ideas to respond to the needs of cyclists.

Global equity markets had a difficult April, suffering substantial weakness over the month. The MSCI World Index was particularly hard hit, recording its worst monthly return since the start of the COVID-19 pandemic. The NASDAQ Composite Index posted a 13.2% fall in US dollar terms – its sharpest decline since October 2008. Market weakness was also evident elsewhere with the Euro Stoxx 50 Index ending 7.7% lower, the FTSE 100 Index down 3.9% and the Nikkei 225 Index tumbling almost 10% (all in US dollar terms).

The month was full of corporate earnings announcements in which many technology giants announced disappointing results. This impacted many global and US indices, which generally carry a large allocation to these technology names. Amazon fell by 14% after recording its slowest revenue growth in the first quarter and reporting weak guidance. Netflix fell by around 40% after revealing its subscriber growth had turned negative for the first time, while also warning of further subscriber losses. Despite delivering solid results, Apple also fell after detailing the challenges that lie ahead for its supply chain.

Adding to the tribulations were concerns that more interest rate rises were imminent, further lockdowns in China following a surge in COVID-19 cases, and the ongoing conflict between Russia and Ukraine. From a sector perspective, only consumer staples ended the month higher while all others suffered declines. The worst-performing sectors were communication services, consumer discretionary and information technology.
