Takeover bid for AstiVita Limited – Issue of Consideration Shares

Tamawood Limited (ASX: TWD) (**Tamawood**) refers to its all scrip takeover offer for 100% of the fully paid shares in AstiVita Limited (ASX: AIR) (**AstiVita**) (**Takeover Offer**).

Tamawood issued 4,759,027 fully paid shares today to those AstiVita shareholders who accepted the Takeover Offer. Tamawood has now been the registered as the holder of 23,784,846 fully paid shares in AstiVita representing 95.78% of the AstiVita shares on issue.

Tamawood intends to acquire the remaining AstiVita shares pursuant to the compulsory acquisition process under the *Corporations Act 2001 (Cth)* as noted in its announcement of 16 May 2022.
