










The EV market doubled in 2021, 2022 will see growth but there are significant headwinds now


EV PC & LDV penetration rates, %, 2021 vs YTD May-22



EV sales outlook by vehicle class




Supply chain issues are set to remain in the coming years and may well impact demand




Chemistry split over the last 6 months shows a big difference between regions

Battery demand by region




% of EV sales Battery demand chemistry split, 2022




Chemistry choices are a function of use case and geography
