

ASX ANNOUNCEMENT - NEW BOARD APPOINTMENTS

19 July 2022: Health and Plant Protein Group Limited ('HPP' or 'the Company') is pleased to announce the appointment of two new Directors in Mr. Albert Tse and Mr. Hugh Robertson effective immediately. Mr Tse has taken on the role of Executive Chairman, while Mr Robertson has been appointed as an Independent, Non-Executive Director.

These Board appointments follow Mr. Dennis Lin's decision to retire as Executive Chairman of the Company, following expiry of the current term under his executive contract. Hugh has over 15 years of advisory and board experience across a range of industries including FMCG, Food and Agriculture, Technology and Financial and Professional Services. Hugh is currently a Director, Corporate Finance at Bell Potter Securities Ltd.

They have overseen a number of key initiatives including the integration of the RHO branded products and material ranging across the US market as well as receiving efficiencies across the existing business units. In accordance with the Company's Constitution Mr. Robertson will stand for election by Shareholders at the next AGM. The terms of Mr. Tse's engagement in his executive role are being finalised and will be notified to the market when available.
