QUARTERLY CASH FLOW AND ACTIVITY REPORTING

Academies Australasia Group Limited (ASX: AKG) today released the Quarterly Cash Flow Report for the period 1 April to 30 June 2022, which is attached.

The information is not audited.

During the quarter under review, similar to the previous three quarters, there was no significant change in the activities of the AKG group since the FY21 Annual Report.

This is AKG's fourth Quarterly Cash Flow and Activity Report. For every one of the four quarters, AKG reported positive net cash from operating activities.

Net cash from operating activities for the period 1 April to 30 June 2022 was \$3.3 million. Net cash from operating activities for FY22 was \$9.3 million.

It would also be relevant to note that AKG has:

- no bank borrowings,
- cash of \$16 million, and
- its full Listing Rule 7.1 placement capacity available to it and can conduct a rights issue or other form of offering on an urgent basis, should it require additional equity capital.
