## Proposed settlement of ASIC action against Australian Mines

Australian Mines Limited (ASX: AUZ) ("Australian Mines" or "the Company") refers to its announcement dated 10 May 2022 concerning civil proceedings commenced by ASIC against the Company (the Proceedings).

The Proceedings relate to certain announcements by the Company to the ASX between 19 February 2018 and 27 June 2018 with respect to the Sconi Project and the Term Sheet for an Offtake Agreement entered into between the Company and SK Innovation Co Ltd.

The Company and ASIC have agreed, subject to approval by the Federal Court, to settle the Proceedings by the Company making certain admissions of contraventions of its continuous disclosure obligations. The Company and ASIC will also make a joint submission to the Federal Court that the appropriate penalty is \$450,000. The Company will also pay ASIC's costs in the amount of \$55,550. As stated, the settlement and penalty are subject to approval by the Federal Court.
