**Major Shareholding Disclosure – Fat Prophets Global Contrarian Fund Ltd (the “Corporate”)**

It is with regret that we bring to the Exchange’s attention a delayed Major Shareholding filing by Mirabella Financial Services LLP (“MFS”), the details of which are set out below. The corrective filing is attached here.

Effective 10 March 2022, a 11% threshold was breached with an overall position of 11.148%. The reason for the delay was due to Mirabella’s data service provider not capturing a share buyback in respect of the Corporate and therefore misrepresenting total voting rights in the Corporate. This incorrect data resulted in MFS not being able to identify that the threshold was breached.

The discrepancy in total voting rights in the Corporate was identified when MFS changed its data service provider and inconsistencies in the number of total voting rights were uncovered. In respect of the Corporate, MFS then verified the position manually using information obtained directly from the Exchange.

To confirm, MFS has changed the data service provider since the initial incident which therefore minimizes the risk of recurrence.
