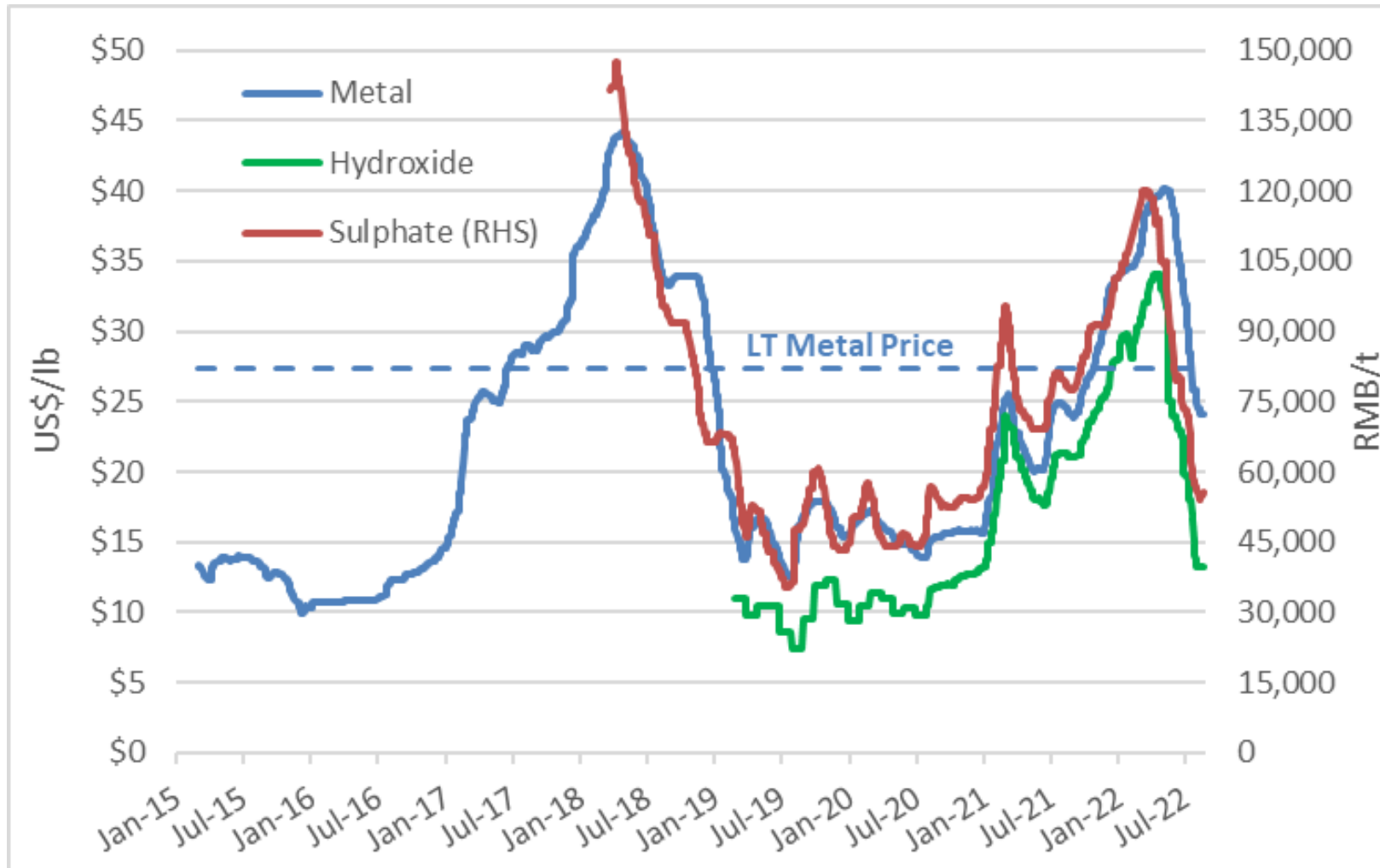

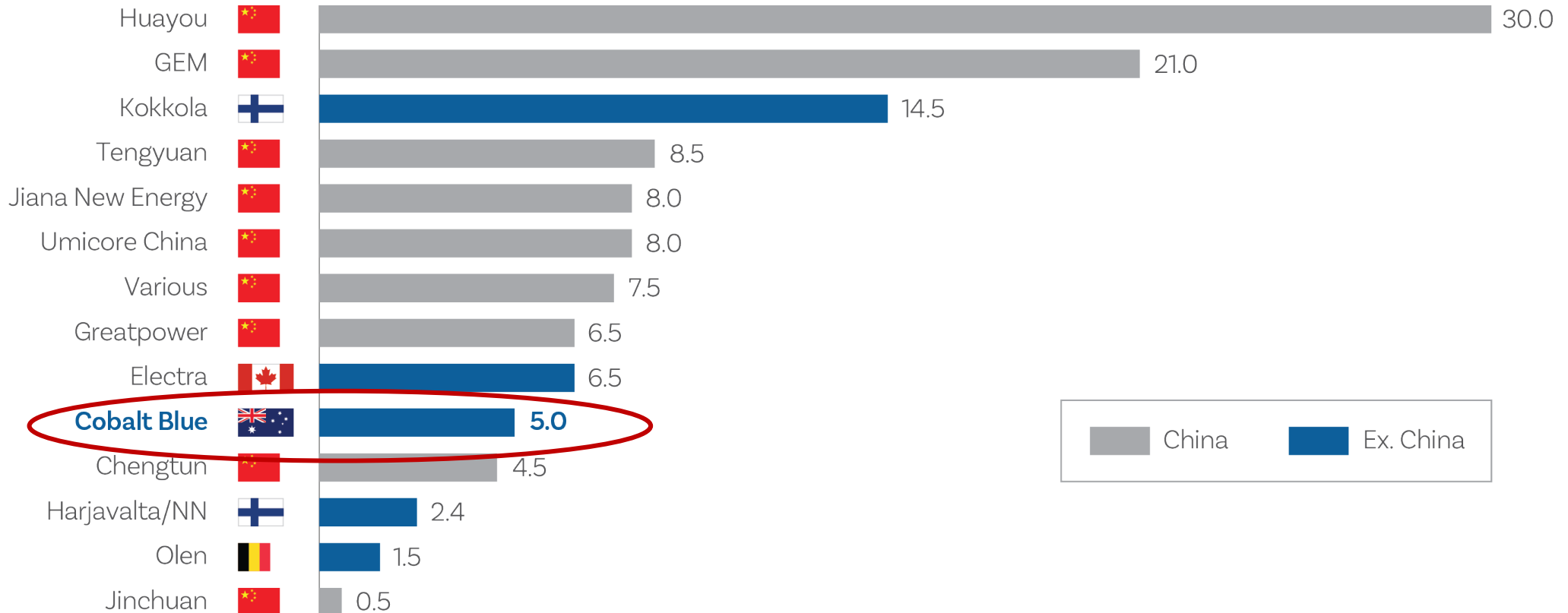

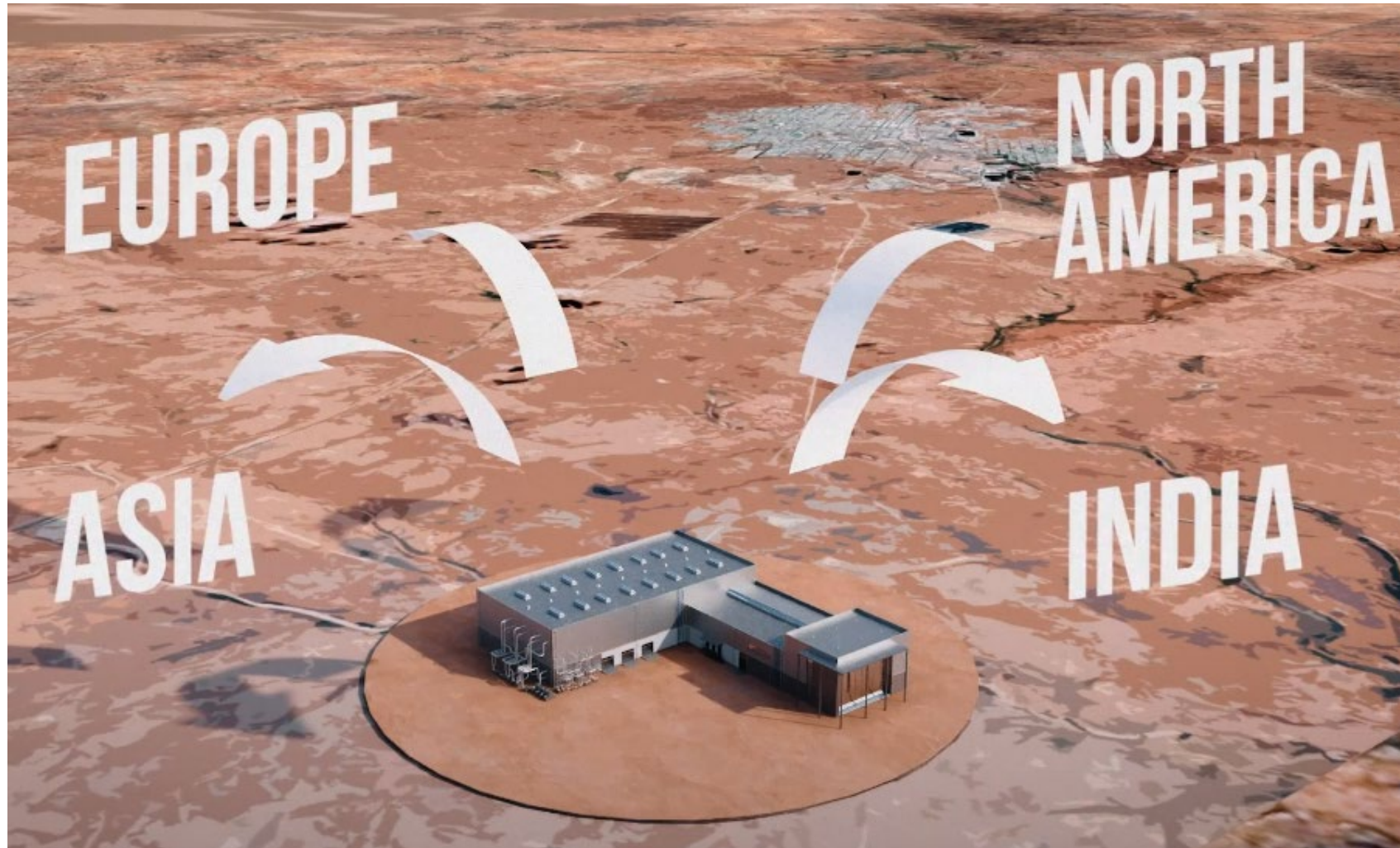
# Australian battery metal refining hub?
