**Net Asset Value as at 26 August 2022**

The weekly estimated unaudited net asset value (NAV) before withholding tax as at 26 August 2022 was \$0.65\* per unit.

If estimated tax on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value as at 26 August 2022 would be \$0.59\* per unit.

**Calculation of weekly NAV**

This weekly unaudited NAV estimate has been calculated by reference to the Fund's most recent estimated unaudited fully diluted monthly NAV at 31 July 2022 now reflecting the audited property valuation in the 30 June 2022 half year financial report released on 30 August 2022 (being \$0.64 per unit on a pre-tax basis and \$0.58 per unit on a post-tax basis which applied an AUD:USD foreign exchange rate of 0.6985), adjusting for changes in the AUD:USD foreign exchange rate, ordinary units outstanding (calculated on a fully diluted basis) and units issued on 25 August 2022 under the Fund's distribution reinvestment plan.

The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 26 August 2022 was 0.6897.

These weekly estimates do not take into account all intra-monthly accruals, which are incorporated in the monthly NAV updates.
