The CDIs are traded on the Australian Securities Exchange (the "ASX") and are held by CHESS Depositary Nominees Pty, Limited, a subsidiary of ASX Limited, the company that operates the ASX. Also includes 62,300 restricted stock units, each of which represents a contingent right to receive one share of the Issuer's common stock upon vesting.
