Cleansing notice under Section 708A (5)(e) of the Corporations Act

Breville Group Limited (“the Company”) issued 321,616 fully paid ordinary shares (Shares) in the capital of the Company on 7 September 2022 as a result of the vesting of Deferred Base Remuneration Share Rights and Performance Rights issued under the Company’s Employee Share Plan. The Company has applied for quotation of the Shares on the ASX as at that date.

The Company gives notice under section 708A (5)(e) of the Corporations Act 2001 (Cth) (the “Corporations Act”) that:

1. the Shares were issued by the Company without disclosure to investors under Part 6D.2 of the Corporations Act;

 - (i) the assets and liabilities, financial position and performance, profit and losses and prospects of the Company; or
 - (ii) the rights and liabilities attaching to the Shares.
