## Re: WDS- CitiFirst Self-Funding Instalment Dividend Announcement - Estimated

Citigroup Global Markets Australia Pty Limited as Issuer of the WDS CitiFirst Self-Funding Instalments (ASX code WDSSOA, WDSSOB, WDSSOC, WDSSOD, WDSSOE, WDSSOF & WDSSOQ), declared the record date for entitlements to the estimated AUD 1.6179, fully franked dividend for the WDS CitiFirst Self-Funding Instalment is 9 September 2022, coinciding with the record date for WDS ordinary shares.
