Issue of Shares on Conversion of Notes

Vectus Biosystems Limited (ASX:VBS) (Vectus or the Company) advises that it has issued a total of 763,529 fully paid ordinary shares as follows:

- A total of 680,000 fully paid ordinary shares to two note holders following the conversion of 680,000 convertible notes, at a conversion price of \$0.50 per note.
- In relation to the accumulated interest on these notes, at an interest rate of 6% per annum and as provided for in the Convertible Note Deeds, the two note holders have elected to have the interest paid as 83,529 fully paid ordinary shares calculated at \$0.77 per share.
