Atlantic Lithium Limited (ASX: A11) – Admission and Quotation

Description

Atlantic Lithium Limited ('A11') was admitted to the Official List of ASX on Wednesday, 21 September 2022.

The securities of A11 will commence quotation at 12:00PM AEST on Monday, 26 September 2022.

Under A11's replacement prospectus dated 29 August 2022 (the 'Replacement Prospectus') issued by A11 and Atlantic SaleCo Limited ('SaleCo'), A11 and SaleCo raised approximately \$13,253,000 by the issue and transfer of 22,850,000 ordinary fully paid shares at \$0.58 per share, and approximately \$4,469,534 by the exercise of 15,500,000 options at various exercise prices.
