Board Changes

Epsilon Healthcare Limited (ASX:EPN) (Epsilon or the Company) advises that Mr Patrick Baiyu Xu has resigned as a director of the Company effective 21 September 2022, and separately Mr Alan Beasley has been appointed to the Board effective 22 September 2022.

Mr Patrick Xu's resignation was immediately prior to his conduct of an off-market transfer on Wednesday of his 5.9% interest in the Company (17,647,059 FPO) to a third party at \$0.0425 per share – a premium of over 84% to the last traded price.

Following these changes, the Company advises that Mr Steven Xu will return to a non-executive Chairman role. As a result, the composition of the Company's Board of Directors is Mr Steven Xu as non-executive Chairman, and Messrs Simon Rowe and Alan Beasley as non-executive directors.

Chairman, Steven Xu commented:

"We welcome Mr Beasley on to the Board as he brings his significant previous experience as a former long term director of this Company. I look forward to working closely with him as a fellow director again. We will look to provide further updates to the market as we progress our strategic vision for Epsilon in due course."
