## UPDATE ON SCHEME - LODGMENT OF COURT ORDERS

Absolute Equity Performance Fund Limited (**AEG**) is pleased to confirm that a copy of the orders made on 21 September 2022 by the Federal Court of Australia approving the Scheme of Arrangement between AEG and its shareholders (**Scheme**) have today been lodged with the Australian Securities and Investments Commission (**ASIC**).

Accordingly, under section 411(10) of the Corporations Act, the Scheme is now legally effective.

Accompanying this announcement is a copy of the Court's orders lodged with ASIC.

AEG Shares will be suspended from the close of trading on ASX today.

The number of New WAM Leaders Shares to be received for each AEG Share will be based on the relative pre-tax NTA per share of AEG and WAM Leaders calculated as at 5.00pm (Sydney time) today. The final exchange ratio will be announced once both AEG's and WAM Leaders' pre-tax NTA has been confirmed as required under the Scheme.

The timetable for the implementation of the Scheme is set out in AEG's announcement of 19 September 2022.
