## Westpac proposal to exit Westpac Self-Funding Instalments and customer offer

Westpac Banking Corporation (ACN 007 457 141) (**Westpac**) as the issuer of Westpac Self-Funding Instalments (**Westpac SFIs**) proposes to exit Westpac SFIs by putting a vote to Holders that includes an Accelerated Completion Date and customer offer.

The decision follows changes in Westpac's strategy to simplify its business and focus on core banking in Australia and New Zealand. The wind-down in Westpac SFIs commenced in November 2020 when we ceased issuing new Westpac SFIs and moved to "bid only" support for Westpac SFI trading.

As a result, Westpac will offer customers a reduction in their Loan Amount of 25% to support the exit. There are currently less than \$6 million of loans outstanding in respect of Westpac SFIs held by approximately 90 customers.

To exit Westpac SFIs, Westpac is required to put resolutions (collectively, the **Resolutions**) to a Holder vote to enable it to amend the Terms of Issue to bring forward the Completion Date for all Westpac SFIs to 17 November 2022 (indicative).

## Summary of Westpac's proposal

The key parts of Westpac's proposal are:

- 1. Inserting an additional "Extraordinary Event" into the Terms of Issue to allow Westpac to fix an Accelerated Completion Date, bringing this date forward from the currently scheduled Completion Date of 13 June 2024 to 17 November 2022 (indicative).
- Reducing the Loan Amount outstanding under the Loan Agreement for each Westpac SFI at the date of the Holder meeting by 25% (the Loan Reduction Amount) in the event Westpac fixes an Accelerated Completion Date.

The Resolutions are consistent with the ASX Operating Rules, which allow the Terms of Issue to be amended with the approval of 75% of votes cast by Holders who vote on the Resolutions. Holders will be entitled to cast one vote for each Westpac SFI they hold.

A Holder meeting has been scheduled for 2pm (Sydney Time) on Tuesday, 18 October 2022. Westpac presently intends to declare an Extraordinary Event if the Resolutions are passed, but it reserves the right not to do so.
