## **FY2022 AUDITED FINANCIAL STATEMENTS**

TerraCom Limited (ASX:TER) (**TerraCom** or **Company**), is pleased to provide its FY22 Annual Report, which includes the audited consolidated financial statements.

### **RESULTS SUMMARY**

There were several adjustments associated with the deconsolidation of the South African operations which resulted in an overall increase to the profit after income tax of \$33.5 million. The deconsolidated calculations covered a number of operations within the Company's South African Business Unit and the nature and extent of audit procedures performed was extensive.
