StarVale update

Jumbo Interactive Limited (**Jumbo**) announced to the ASX on 27 January 2022 that it had entered into an agreement to acquire the StarVale Group, subject to obtaining regulatory approval from the UK Gambling Commission which was originally anticipated by the end of FY22 and subsequently by the end of Q1FY23. Such regulatory approval is still pending, however Jumbo anticipates receiving approval imminently.

Jumbo remains confident of obtaining the relevant regulatory approvals and broadening its Managed Services footprint in the UK not-for-profit sector.
