**Form 604 Correction – Coronado Global Resources Inc. (CRN)**

L1 Capital Pty Ltd (ABN 21 125 378 145) (**L1 Capital**) notes that the filing of the “notice of change of interests of a substantial holder” form (**Form 604**) for CRN lodged with the Australian Securities Exchange (**ASX**) and CRN on 08 March 2022 was incomplete.

The Form 604 was incomplete in that it inadvertently omitted the relevant consideration amount of \$92,565,354.00 having been paid to L1 Capital for the sale of 47,619,242 securities.

Attached to this letter is an amended Form 604, which has been lodged for the sole purpose of correcting the previous Form 604.

A copy of the amended Form 604 has also been lodged with CRN.

For completeness, L1 Capital notes that it lodged a “notice of ceasing to be a substantial holder” (**Form 605**) on 17 March 2022.
