# CitiFirst Warrants over Telstra Corporation Limited ("TLS")

#### Scheme of Arrangement

On 19 October 2022, TLS received court approval for its Scheme of Arrangement ("**Scheme**"). The scheme is a legal re-organisation of TLS into Telstra Group Limited.

Under the Scheme, existing shareholders in TLS will receive one Telstra Group Limited share for each existing TLS share.

Telstra Group Limited commences trading on the ASX on 21 October 2022.
