The CitiFirst Reset Instalments issued by Citigroup Global Markets Australia Pty Limited (ABN 64 003 114 832 and AFSL 240992) under the Product Disclosure Statement dated 24 November 2017 are due to be reset on 18 November 2022 ('Reset Date').

The purpose of this letter is to explain your options as the Reset Date for your investment approaches. You may choose to:

- **A.** Do nothing ("Automatic Reset Process");
- B. 'Lock In' your Reset Cashback / Reset Payment;
- C. Sell your Reset Instalments on the ASX on or before 18 November 2022;
- **D.** Deliver a Request for Purchase Notice (and exercise your put option); or
- **E.** Pay us the Final Instalment and receive the Underlying Shares;

## If we don't hear from you by midday Sydney time on 18 November 2022, (A) will apply.

We enclose a more detailed explanation of these options (A through E) in Attachment 1. It is important that you understand your options and consider carefully whether you wish to take action at this time. If you choose to reset your CitiFirst Reset Instalments at this time, or your instalments are automatically reset, your Reset Statement will be mailed to you in December 2022. This should be kept as your confirmation of the details of your reset.
