# **Existing Facility**:

The Company has an existing credit facility with shareholder Wagering Technology Pty Limited for \$550,000 of which \$550,000 had been drawn down at the end of the quarter.

The terms of the loan are:

- Interest: 10% p.a.
- Interest payable every 6 months in arrears
- Term of the loan: 12 months if the loan is not repaid in full in cash by the Termination Date, the borrower may extend repayment of the Loan and payment of all interest by a further 12 months
- Security: Unsecured.

### **Proposed Additional Facility:**

AMRAM Corp Pty Ltd has committed to lending \$500K in funds, as an overdraft facility. AMRAM Corp Pty Ltd and BIR Financial Limited have common Director, Mr Jody Elliss. The terms of the facility will be:

• Interest: 12% p.a.

No – Subsequent to the end of the quarter there has been an improvement in operating activities as a result of actions taken in earlier quarters. This is expected to improve further during the quarter.

Answer: The company is finalising a new overdraft facility.

Additionally, there has been improvement in cash flow recorded subsequent to the end of the quarter. There are also plans for the commencement of a new business division.

Answer: Yes. The company is continuing to discuss new business opportunities which will enhance its cash position.
