Answer: No. The cash outflows in September 2022 quarter were for potential new business acquisition.

- Answer: Yes, the Company has done an initial capital raising of \$300,000 and is in the process of more capital raising.

Answer: Yes. After the restructure of the Company with the DOCA, all liabilities have been eliminated. As announced to ASX on 27 January 2022, Impelus Limited is considering acquiring a new business that requires compliance with Chapter 1 and Chapter 2 of the ASX.
