	The company has a US\$7.5 million debt facility (US\$5.43 million loan availability) with Macquarie Bank Limited which matures in September 2024. The facility is supported by its gas production assets in the Appalachia region of the USA and carries an interest rate of US LIBOR+650bps. Empire made a US\$137,500 debt repayment during the Quarter reducing the outstanding balance from US\$5,575,010 to US\$5,437,510.
