On 24 March 2022, the Company entered into a new term loan facility of \$1,294,125, secured against future R&D refunds to be received by the Company and its wholly owned subsidiary AtCor Medical Pty Ltd. The facility is a prepayment of forecasted R&D tax incentive claim for the year ended 30 June 2022, with a termination date of 31 October 2022. Currently the facility attracts interest at 1% per calendar month (12%pa). Subsequent to the end of the quarter the Company negotiated terms for an extension to the term loan facility and will shortly release an announcement to market confirming the below indicative terms substantially negotiated with the lender:

- Expiry of facility: 31/12/23;
- Interest rate: 1.33% per calendar month (16%p.a) effective from 01/11/22;
- CardieX's full 2022 R&D tax incentive refund to be applied to the current balance owed and tax return to be lodged no later than 31/01/23;
- Any balance after that 2022 R&D refund has been offset can be:
  - Paid out in cash with no interest or fees payable under the current facility terms following the month end of the FY2022 R&D payout; or
  - Secured against the Company's FY2023 R&D refund and paid on or before the end of the extended facility term of 31/12/23.

Yes. The Company has taken steps during the quarter through conducting both a placement and an SPP to raise additional funds. As at the date of report there is \$1,000,000 in placement funds from Directors yet to be receipted that will be subscribed subsequent to the Company's AGM on 30 November 2022 (assuming requisite approvals for the placement are received).

The Company has also anticipated that it will receive funds from its operations and existing business over the coming quarter commensurate with its prior annual run rate (noting that this quarter was below that run rate) which should assist in the reduction of the net operating cash position for the coming quarter as reported at Item 8.5 above.

#### Answer:

Yes. The Directors believe that if required, the Company has the ability to raise additional capital on a timely basis and has a proven capability of doing so.
