Answer: Yes. Operating cashflow in the next quarter will be approximately the same as this quarter but then reducing in the following period due to wet season in North QLD

Answer: Yes. After the September quarter NMR has completed the Rights Issue shortfall to raise a total of \$2,147,783. Of this, \$803,178 is disclosed in section 3.1 above, leaving a balance of \$1,344,605 (excluding any costs) to be included in the subsequent quarter. These funds will assist the business through the next quarter and beyond.
