	The Company has a loan facility available to it provided by Bizzell Nominees Pty Ltd an entity associated with the Company's Chairman. The facility is for up to \$6.5 million, interest rate on drawings is 8% and the facility is secured by a fixed and floating charge over the assets of the Company. As at 30 September 2022 the facility has been drawn to \$2,558,000. In addition the Company has a short term loan facility provided by Norfolk Enchants Pty Ltd, an unrelated third party. The facility is for up to \$2m, has an interest rate of 12% per annum and is repayable on 31 October 2022. The facility is secured by a fixed and floating charge over the assets of the Company. As at 30 September 2022 the facility has been drawn to \$2,000,000.
