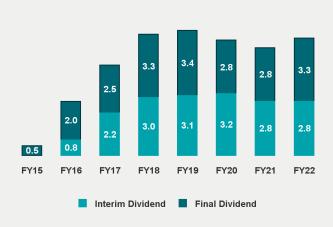

DIVIDENDS IN CENTS PER SHARE

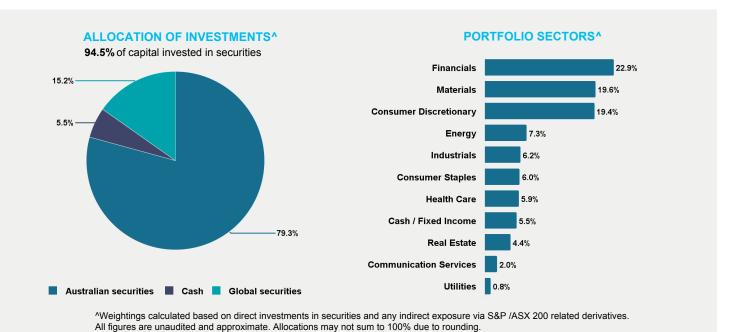

PORTFOLIO COMMENTARY

Share markets rose sharply in October off the back of a strong lead from Wall Street early in the month and this was supercharged on 4 October when the Reserve Bank of Australia (RBA) surprised markets by opting to raise interest rates by 0.25% instead of the widely expected 0.5%. The market immediately priced in a lower terminal cash rate in futures markets and equities surged by 3.75% on the day, the largest bounce in over two years. The RBA's moves reflected around the world and sparked hopes that Australia was leading a pivot by other central banks towards a less aggressive monetary stance. The RBA's Financial Stability Review noted that stability risks had increased with the tightening of financial conditions. Whilst the review said banks continued to be liquid and well capitalised there were risks from a disorderly decline in asset prices, loan arrears and defaults.

Australian inflation accelerated to a new 32 year high in the September 2022 quarter well ahead of market expectations, with headline Consumer Price Index (CPI) up 7.3% year on year versus consensus +7.0% and up from +6.1% in the June quarter of 2022. The Federal Government delivered a no-surprises budget on the 25 October which sought to contain inflation and manage rising household financial strains.

Globally, it was all politics and policy worries that drove markets. Surprisingly strong US employment data kept the US Federal Reserve (Fed) on alert for another 0.75% hike in rates in November. Meanwhile the UK government's poorly received budget sent bond markets into turmoil which led to the ouster of the UK Chancellor (finance minister) and Prime Minister in quick succession. Currency markets were also very volatile with the yen at generational lows (lowest since 1998) and the UK pound flirting with 40 year lows. The Australian dollar looked like it might slip below 60 cents as an aggressive Fed and dovish RBA chafed. The Chinese Congress re-elected Xi Jinping as leader which worried markets about the continuation of the COVID-19 zero policies. Many growth technology stocks in the US faced a turbulent reporting season. Meta plummeted to US\$93 on the 31 October, down a whopping -75% from its September 2021 highs of nearly US\$379.

The PIC portfolio in October returned 5.5% compared to the S&P/ASX300 Accumulation Index (benchmark) which returned 6.0%. Financials, Real Estate and Energy were the place to be during October as banks and insurers rallied, oversold property vehicles returned to favour and energy prices remained high. The Materials sector was more challenged, as were the expensive Consumer Staples and Healthcare sectors as rising global bond yields took their toll. Detractors to the portfolio were metal companies, Iluka Resources Limited (ASX: ILU) 29Metals Limited (ASX: 29M) and Jervois Global Limited (ASX: JRV). Despite all the global volatility, our key global positions performed well led by Flutter Entertainment Plc (LON: FLTR) which rose +20.5% in October which continues to grow well in advance of its competition.

The financials sector was up 12.1% in October. Bank of Queensland (ASX:BOQ) released its 2021-22 annual results and indicated a better-than-expected net interest margin (NIM) figure that underpinned investor support for the banks. The NIM is the amount of money paid by banks for access to funds, deposit-holders, less the interest paid by the banks to savings deposit-holders. BOQ's clear trend of NIM improvement into and beyond the end of the reporting period has seen the market recalibrate their estimates for the banking complex. Given the relative competitive positioning and deposit funding strength of the four majors, the Manager believes BOQ stands to benefit disproportionately. Accordingly, the Manager considers Westpac Banking Corporations (ASX: WBC) to be better positioned for the PIC portfolio. In October, Westpac delivered the strongest return amongst the big four, up +16.9%.

Rising interest rates are helping to buoy lending profitability at Australia's biggest banks but there is also uncertainty with the economy expected to slow. A major part of the Westpac's revenue comes from net interest income, whose components are NIM and asset growth. Westpac's NIM increased from 1.85% in 1H22 to 1.9% in 2H22, which assisted its net interest income to increase by 7% over the period. These higher rates of income growth have two benefits. Firstly, they enable income to grow faster than expenses which increases the company's return on equity (ROE); and secondly, they produce higher rates of profit growth, all else being equal. Both these characteristics lead to higher share price multiples. The Manager believes Westpac should trade on a multiple much closer to National Australia Bank (ASX: NAB) as a result of its higher weighting towards the higher-returning retail business. It is also the only major bank which is actively seeking to reduce its expenses, and this will lift its share price multiple should it succeed. Westpac is the largest position and as at 31 October 2022, comprised 12.3% of the PIC portfolio.
