Retraction of 2 x Appendix 3Y

- Current holding details had not been updated from the previous notice for 2 x Appendix 3Y Change of Directors Interest Notice filed 17.11.2022

Magnis Energy Technologies Ltd ("Magnis", or the "Company") (ASX: MNS; OTCQX: MNSEF; FSE: U1P) released the Notice of Meeting and blank Proxy Form through the ASX on 17 October 2021. It has been noted that there were some inconsistencies between the Proxy Form, the Notice of Meeting and the Explanatory Memorandum which require correction.

Consequently, these documents are retracted, and a new Notice of Meeting and blank Proxy Form will be released that address the inconsistencies.

Fortunately, no documents had been dispatched to Shareholders. The new replacement Notice of Meeting & Proxy Form are what will be posted to shareholders in accordance with the timetable that satisfies the notice requirements for the Annual General Meeting which is to be held on 24 November 2022.

Magnis also has a minority stake in C4V and has also exclusively licensed their anode technology to produce high quality, high performance anode materials from Magnis' Nachu Graphite project in Tanzania. The company's vision is to enable, support and accelerate the green energy transition critical for the adoption of Electric Mobility and Renewable Energy Storage.
