## Big River Industries (ASX: BRI) Announces appointment of new Chief Executive Officer

After a thorough search and review of both internal and external successor candidates, current Big River Industries executive, John Lorente will be appointed to the CEO role and Director effective 1 March 2023.

## Appendix A.

Summary of key terms of John Lorente employment agreement.

Commencement Date: 1 March 2023

**Term:** Appointment on an on-going basis subject to termination by either party with 6 months' notice (or payment in lieu), other than where the employment is terminated for cause in which case Big River Industries may terminate with no notice period.

**Total Fixed Remuneration (TFR):** \$500,000 per annum inclusive of superannuation contributions and salary sacrifice arrangements.

**Short Term Incentive:** Eligible to receive a target STI of up to 25% of TFR with the opportunity to earn a further 20% of TFR for the successful achievement of other additional stretch financial targets.

**Long Term Incentive:** The current LTI arrangements commensurate with John's existing role will remain in place for the remainder of the 2023 Financial Year. John will participate in in future financial year LTI arrangements consistent with what is currently in place for the out-going CEO. Further details of this will be provided as required in future reporting periods.

**Post-employment restrictions**: The agreement contains post-employment restraints which are typical for this level of employment.
