## Appendix 3G Late Lodgement

Bigtincan Holdings Limited (**ASX:BTH**) ("**Bigtincan**") refers to the attached:

- Appendix 3G for the issue of options on various dates between 4 April 2022 and 25 October 2022 under the ESOP, that were issued under Bigtincan's Listing Rule 7.1 placement capacity, shareholder approval for the issue was received at the Annual General Meeting held on 22 November 2022;

These Appendix 3Gs were lodged outside the time prescribed by the Listing Rules. The late lodgement is the result of an administrative oversight due in part to Bigtincan transitioning to a new service provider for the management of its employee share plans.

Bigtincan has reviewed its processes and believes they are adequate to ensure that disclosures are released to the ASX in accordance with the requirements of the Listing Rules.
