BOARD CHANGES FOLLOWING COMPLETION OF U.S. ASSET SALE

New Energy Solar (ASX: NEW, the **Company**) announces changes to the board of the Company (**Board**) following completion of the U.S. asset sale through the sale of NEW's shareholding in NES Galaxy, LLC to MN8 Energy which was announced on 21 November 2022.

Mr Jeff Whalan, Chair, has resigned as Chair and a director of the Company. In addition, Mr John Martin and Ms Maxine McKew have resigned as non-executive directors of the Company.

Non-executive director, Mr James Davies, has been appointed to the role of Chair of the Company and Ms Caroline Purtell, who is also the NEW Company Secretary, has been appointed as a non-executive director of the Company. Non-executive director, Mr John Holland, remains on the Board. The Board thanks Jeff, John, and Maxine for their contribution. Appendices 3X and 3Z detailing the abovementioned directors' holdings in the Company at their resignation and appointment dates (as relevant) are attached.

These changes to the Board are consistent with the intention of the Board to wind up the Company by the end of 2023. Shareholder value remains the Board's priority, including the need to reduce running costs and maximise final proceeds, as the Company is wound up.
