## **Funding Update – Director Loan**

Mariner Corporation Limited (ASX:MCX) (**Company**) wishes to advise that Mr Liping Cai Executive Chairman of the Company, has agreed to provide the Company with a short term, unsecured loan of A\$50,000 on commercial terms. The loan is not convertible into shares.
