## FORAGER AUSTRALIAN SHARES FUND (ARSN 139 641 491) (ASX: FOR) SUSPENSION OF DISTRIBUTION REINVESTMENT PLAN (DRP)

On 16 December 2022, an Appendix 3A.1 was lodged with the ASX, advising an <u>indicative</u> distribution of \$0.03 per unit for the period ended 31 December 2022 and suspension of the DRP.

FOR is currently trading at a material discount to Net Asset Value and it is not deemed to be in the best interests of unitholders to re-invest the distribution under the current DRP plan. Therefore, the Responsible Entity has suspended the operation of the DRP until further notice.

With the suspension of the DRP, all FOR unitholders will receive their FOR distribution in cash.
