TRADING HALT REQUEST

Range International Ltd [ASX:RAN] (**Company or Range International**) hereby requests a trading halt in relation to the Company's ordinary shares quoted on the Australian Securities Exchange (ASX) in accordance with ASX Listing Rule 17.1.

The trading halt is requested pending an announcement by the Company to the market regarding an update on the ITO Amended Assessment relating to FY2018 (**the Purpose**).
