Notice under section 708A(5)(e) of the Corporations Act 2001

This notice is given by Core Lithium Ltd (ABN 80 146 287 809) (the **Company**) under section 708A(5)(e) of the Corporations Act 2001 (**Corporations Act**).

The Company has issued the following ordinary shares (**Shares**), together, the **Share Issue**.

- 5,000,000 Shares at an issue price of A\$0.06 per Share to directors upon exercise of unquoted options on 3 January 2023; and
- 40,000 Shares at an issue price of A\$0.45 per Share to investors that have exercised unquoted options on 3 January 2023.

- (a) the Shares were issued without disclosure to investors under Part 6D.2 of the Act;
- (b) this notice is being given under section 708A(5)(e) of the Act;
- (c) as a disclosing entity, the Company is subject to regular reporting and disclosure obligations;
