The Restricted Share Awards (RSUs) were issued under the Company's Equity Incentive Plan. Each RSU is a right to acquire a fully paid ordinary share in the Company or, at the discretion of the Board, receive the Cash Equivalent Value, subject to satisfaction of the vesting conditions.

The RSUs vest in three tranches, subject to continuous employment with the group being:

1. 33% of RSUs vest on the date of release of CleanSpace's full-year results for the year ending 30 June 2023 (expected to be in or around August 2023);

2. 33% of RSUs vest on the date of release of CleanSpace's full-year results for the year ending 30 June 2024 (expected to be in or around August 2024); and

3. 34% of RSUs vest on the date of release of CleanSpace's full-year results for the year ending 30 June 2025 (expected to be in or around August 2025).
