### Correction Notice – Appendices 3G and 3Y

**Sydney, Australia** – Global software company Nuix (‘the Company’, ASX: NXL) refers to the Appendices 3G and 3Y released to the market on 20 December 2022 in relation to the issue of certain performance rights to the Chief Executive Officer, Jonathan Rubinsztein (**Appendices**).

It has come to our attention that there was a minor error in these Appendices which we wish to correct. The Appendix 3G listed an issue date of 16 December 2022 and the Appendix 3Y listed a date of change of 16 December 2022. The Appendices should have listed the date 14 December 2022 instead of 16 December 2022.

The corrected Appendices are attached.
