Beforepay Q2 FY23 Quarterly Activities and Appendix 4C Cash Flow Report (Unaudited)

Beforepay delivers strong growth, reduced operating expenses with defaults showing expected seasonal increase in Q2 FY23

Beforepay Group Limited (Beforepay or the Company) (ASX: B4P) has released its Appendix 4C for the quarter ended 31 December 2022 (Q2 FY23).

Beforepay continues improvement across key metrics in Q2 FY23. Highlights include:

- Continued strong growth, with pay advances of \$164.7m, up 114% from Q2 FY22 (year-on-year or YoY) and up 18% on Q1 FY23 (quarter-on-quarter or QoQ).
- Net transaction margin (NTM) was \$1.82m, down from \$3.23m or (44%) QoQ and up 911% YoY from \$0.18m in Q2 FY22. The quarter result was driven by increases in pay-advance volumes offset by expected seasonally higher defaults in the quarter.
- Underlying EBITDA loss increased to (\$3.01m), up 28% from (\$2.34m) in Q1 FY23, driven by a
  decline in NTM due to seasonally higher net transaction loss (NTL). The EBITDA loss was partly
  mitigated by reduced operating expenses.
- Balance-sheet strength with \$18.7m in cash on hand as at 31 December 2022.

Beforepay CEO Jamie Twiss, said, "Beforepay has continued to grow and perform strongly, with total volume of pay advances up 18% in the quarter and 114% year-on-year. With more than 200,000 active users, continued strong underlying growth, and flat or declining operating costs, we continue to execute our strategy of moving quickly towards profitability. The expected seasonal increase in defaults reduced net transaction margin in the quarter."



#### Financial Performance – Q2 FY23

- Total Pay Advances grew by 114% YoY to \$164.7m driven by both new customer acquisition and continued usage by existing customers.
- Active users grew by 47% YoY to 203,937 and up 10% on Q1 FY23 (185,075).
- Beforepay income increased by 138% YoY to \$8.12m in Q2 FY23, up 26% on Q1 FY23
   (\$6.46m). Beforepay generates its revenue through charging users a fixed fee of 5% per cash out received which is recognised over the period in which the customer advance is repaid.
- Net transaction loss % increased to 2.9%, down 7% YoY and up 82% on Q1 FY23. This is driven by a combination of higher limit increases and expected seasonal defaults, both disclosed in our Q1 FY23 quarterly update. In October 2022 management reduced loan limits to address the spike in defaults for loans maturing by mid-December 2022. The net transaction loss was partially offset by recoveries which continued to perform well during the quarter.
- Direct service costs as a percentage of pay advances were flat at 0.3% in Q2 FY23 (previously 0.3% in Q1 FY23). Our direct service costs do not vary with the size of the pay advance amount.
- Net transaction margin % (of pay advances) decreased 52% to 1.1% compared to 2.3% in Q1 FY23, driven primarily by higher seasonal net transaction losses, and up 362% from Q2 FY22.
- Total operating expenses (excluding one off and/or significant items) were \$4.83m in Q2 FY23,

which declined 13% from \$5.57m in Q1 FY23.

- Within these operating expense numbers, advertising and marketing expenses attributable to customer acquisition were \$1.61m in Q2 FY23 or 12% lower than Q1 FY23 (\$1.84m). This was primarily driven by the reduction in above-the-line advertising and additional focus on optimising performance marketing expenditure resulting in average customer acquisition cost (CAC) declining 37% to \$45 in Q2 FY23 from \$71 in Q1 FY23. Employee, general and administration and other costs were \$3.22m in Q2 FY23 or 14% lower than Q1 FY23 (\$3.73m) related to non-recurring one-off employment and recruitment costs and termination costs reflecting the timing of expenditure.
- Underlying EBITDA loss increased to (\$3.01m), up 28% from (\$2.34m) in Q1 FY23, driven by a fall in net transaction margin due to higher net transaction losses in the quarter, partially offset by reduced operating expenses.

#### Outlook

- Consistent with previous years, management expects that defaults will stabilise in line with normal seasonal trends.
- January 2023 month-to-date growth in new user numbers and pay advance numbers have been consistent with the prior quarter.

#### Balance sheet

- Reported cash on hand as at Q2 FY23 was \$18.7m compared to \$21.9m at Q1 FY23, reflecting
  the growth in customer pay advances during the quarter. Cash utilisation of \$3.2m during the
  quarter comprised cash from operating activities (\$7.3m), cash from investment activities (\$nil)
  less cash from financing activities (\$4.1m).
- As at Q2 FY23, Beforepay had drawn \$29.5m under its third-party debt facility (\$15.5m undrawn), up from \$25.3m in Q1 FY23 to fund the net growth in pay advances during the quarter. The thirdparty debt facility has a capacity which increases to \$45.0m by December 2023 and expires in January 2024.
- Beforepay had a total equity position of \$28.5m as at Q2 FY23. This compares to \$30.2m at Q1 FY23.
- Beforepay retains a highly capital efficient model with an average pay advance duration<sup>3</sup> of approximately 25 days. As a result, the third-party funding cost of the average pay advance<sup>4</sup> is c. 0.64% of the amount advanced, based on a 25-day loan duration. A 1% increase in interest rate would increase this to approximately 0.69%.

#### **Growth strategy**

- Beforepay's growth strategy through new customer acquisition and customer retention remains unchanged. The momentum of growth in both revenue and user numbers combined with a positive net transaction margin demonstrates that the Company is successfully executing its strategy.
- The Company remains focused on continuing to grow without adding significant cost to the current operating expense base.

Beforepay will continue to explore new growth opportunities, however, maintains a current focus on its path to profitability by managing costs and delivering on growth in its current products and geographies.

#### Our business

- Beforepay remains committed to providing an ethical, customer-friendly product to help working Australians manage temporary cash-flow challenges.
- Our product advances people small sums of money over short periods of time, which helps them get through short-term challenges whilst not living beyond their means. Beforepay makes ongoing enhancements to customers' eligibility criteria and risk assessments.
- Our fee model is simple, transparent, and affordable, and gives our customers total control, charging only a small transaction fee, zero interest, and never any late fees.
- Average pay advances are small (with an increase to an average of ~\$394 in Q2 FY23), and if a customer does not pay back within the required time, the only penalty is that the service is suspended.
- Beforepay's service remains well regarded by customers, with an average 4.8-star rating (out of 5) across the Google Play Store and Apple App Store.

#### Our customers

- During December 2022, 72% of our customers were in full-time employment, 13% were part-time, 12% were in casual employment, and 2.3% were other<sup>5</sup>.
- The average annual individual customer gross income was \$58,145 during December 2022 (counting only the main source of income)<sup>6</sup>. This is compared to the ABS's individual median income of \$63,000 (as of August 2022)7.
- The four main employment industries for our customers were construction at 13%, retail trade at 11%, hospitality and restaurant services at 11% and healthcare and social services at 10%.
