

**ASX RELEASE****31 January 2023****Successful Conclusion of A\$3 million Placement**

**Kleos Space S.A. (ASX: KSS, Frankfurt: KS1, Kleos or Company)**, a space-powered defence & intelligence technology company, is pleased to announce it has secured A\$3 million via a placement (the **Placement**) having received strong support from both new and existing investors.

15 million new CDIs over ordinary Kleos shares (the **New CDIs**) are expected to be issued pursuant to the Placement, at \$0.20 per New CDI, representing a 9% discount to the last close on 25 January 2023.

River Investment Management, supported by Rivkin Securities, acted as Lead Manager and Bookrunner to the Placement.

Kleos' CEO Alan Khalili commented:

"We are pleased with the strong support received from both new and existing investors in the Placement.

"With our recent advancements in our proprietary technology platform and with proceeds from the Placement we are well placed for our next growth phase."

The Placement will be conducted in a single tranche, with the New CDIs being issued utilising the Company's available placement capacity under ASX Listing Rule 7.1A without shareholder approval being required. New CDIs will rank equally with existing CDIs on issue. Settlement of the Placement is expected to occur on or before Monday, 6 February 2023.
