	Answer: The Company has reduced its expenditure levels in recent months. The Company raises money on a regular basis to fund its operations. The Company received \$250,000 in early October 2022 from share placements approved at a General Meeting held on 29 September 2022. In addition, the Company is in the process of disposing of the Granville tenements with a non-refundable deposit received in the September quarter and further funds of \$375,000 to be received should the sale complete. The Company has been successful in raising funds over many years and recently raised \$1,050,000 (before costs) from a share placement in April 2022.
