Quarterly Activities Report and Appendix 4C for 31 December 2022

- **Hamilton Hotel revenues and occupancy rates increase**
- **Hamilton Hotel contributes positive cashflows to the Innlanz Group**

SYDNEY, AUSTRALIA – 31 January 2023 – Innlanz Limited (ASX: INL) (“Innlanz” or the “Company”), is pleased to provide an update on its quarterly results for the period ended 31 December 2022. A copy of the Appendix 4C -Quarterly Cash Flow Report is attached.

The Company’s total cash position at 31 December 2022 was \$946k which is a decrease of \$316k from previous quarter. Whilst net cashflows used in operations is slightly lower than previous quarter, there had been a repayment of \$220k made to the Bank of New Zealand (“BNZ”) which was previously interest only debt in the books of Heartland Ambassador Hamilton Hotel (“Hamilton Hotel”). Additionally, the Group has unused facilities of \$850k with BNZ should the Company require in future to use it.

The Group’s main income is generated from its hotel asset in Hamilton, New Zealand. The hotel finished the quarter with an occupancy of 84.2% and an ADR (average daily rate) of NZD176.77. The business mix also assisted the hotel to capture more revenue through its other revenue outlets such as the hotel restaurant, as such the hotel finished the quarter with a total revenue of NZD749k.

Cash receipts from operations also include management fees of \$9,996 charged to Ixora Investments Pty Ltd for INL’s Board and Management’s time to provide operational and governance support to Ixora. The management fee has been determined based on time and expertise noting currently NED fees are capped at 25% of the original contracts. Management continues to monitor cash rigorously and is maintaining minimal cash outflows.

The administration and corporate costs for the quarter include \$37k in payment of Non-Executive Directors fees and Managing Director’s remuneration and general administrative costs associated with compliance.

As previously advised, the Company continues to evaluate other potential revenue-generating options to build shareholder value through business development and growth opportunities for the Group.

The Board and Management are appreciative of the ongoing support of our shareholders during these challenging times.
