# Critical Minerals Group Progresses Metallurgical Test Work for Flowsheet and HPA Potential at Lindfield Vanadium Project

### Key Highlights

- Metallurgical test work has commenced in preparation for a processing flowsheet in relation to the Lindfield Project
- Test work has also commenced to determine suitability of ore from Lindfield Project as a feedstock for High Purity Aluminium (HPA)
- Exploration Permit for Minerals (EPM) 28631 has been granted to CMG. EPM 28631 forms CMG's "Whinmoor Project" and is considered prospective for Vanadium and HPA

Critical Minerals Group Limited (ASX: CMG, Critical Minerals Group, CMG or the Company) is pleased to report on key metallurgical testing progress on a number of its exploration projects across its portfolio including where works are currently underway and/or are awaiting results prior to the next phase of work commencing.

## **Lindfield Project Test Work**

CMG is pleased to announce the commencement of the metallurgical test work programs. Work will be conducted to test the ore derived from the maiden drilling program in 2022 to determine the most efficient processing flow sheet for the **Lindfield Project** (EPM 27872). Additional work will also be undertaken by a laboratory specialising in HPA production and technology, to demonstrate whether the ore can be used for HPA production.

## **Whinmoor Project**

CMG is pleased to announce that it has received notification from the Queensland Department of Resources that EPM 28631, forming the **Whinmoor Project**, has been granted to CMG's wholly owned subsidiary CMG 3 Pty Ltd for a five year term.



The Whinmoor Project is located within close proximity to CMG's flagship project, the Lindfield Project, located near Julia Creek in Northwest Queensland.

CMG intends to expand on exploration by previous explorers and known extensions to Vanadium mineralisation in CMG's already defined JORC resource (Inferred 210mt 0.39%  $V_2O_5$ ) of its Lindfield Project (refer to ASX Announcement dated 19 October 2022 and Prospectus dated 25 May 2022).

CMG Managing Director Scott Drelincourt says. "We are excited to commence this metallurgical test work which is an important phase in the development of the Lindfield Project. The ability to conduct metallurgical testing at this stage of the project advances the value of the project significantly as flow sheet design will also impact mining planning and ore treatment. This activity illustrates that work at the Lindfield Project is advancing well.

Further, the granting of the significant area under the EPM at the Whinmoor Project will certainly look to further bolster the company's resource base around its flagship Lindfield Project."
