CLEANSING NOTICE

NOTICE IN ACCORDANCE WITH PARAGRAPH 7(F)(II) OF ASIC CORPORATIONS (SHARE AND INTEREST PLANS) INSTRUMENT 2019/547

This notice is given by Acumentis Group Limited ACN 102 320 329 (ASX: ACU) (“**Acumentis**” or “**Issuer**”) in accordance with paragraph 7(f)(ii) of ASIC Corporations (Share and Interest Plans) Instrument 2019/547 (“**Instrument**”).

The Issuer intends to issue up to approximately 14,285,715 fully paid ordinary shares (“**Shares**”) at an issue price of \$0.07 per Share to eligible shareholders under the SPP offer announced by the Issuer on 2 February 2023, in respect of which offer booklets will be dispatched tomorrow, 8 February 2023. It is a condition of the Instrument that the Issuer gives ASX this notice within 24 hours before the offer under SPP offer is made.

The Issuer advises that:

- (a) the Shares the subject of this notice will be issued under a share purchase plan without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Act**);
- (b) this notice is being given in accordance with the Instrument;
- (c) as at the date of this notice, the Issuer has complied with:
 - (i) the provisions of Chapter 2M of the Act, as they apply to the Issuer; and
 - (ii) section 674 of the Act, as it applies to Issuer, and
- (d) as at the date of this notice, there is no information that is ‘excluded information’ within the meanings of sections 708A(7) and 708A(8) of the Act as if this notice were a notice under paragraph 708A(5)(e) of the Act.
