



Can you explain this barter element?

- Jaxsta now has 350 data partners
- This data is licensed from the copyright owners who deliver the credits daily to Jaxsta
- The original terms with initial key data partners Universal, Warner, Sony, The Recording Academy and Merlin involved a significant fixed cash fee component.
- The licensing fees structure has been renegotiated and Gratis Services are now provided as an alternative to this fixed fee component.
- The accounting of such transactions is shown as per generally accepted accounting principles.
- We also wanted to ensure that we reconciled for shareholders between cash receipts as reported in our Statement of Cash Flows and revenues as reported in our Statement of Profit & Loss.
- Barter revenue represents the contra service value we are providing in the form of Enterprise, Business, Creator subscriptions and Data Solutions to these parties.




API Case Studies
