The Northrop Grumman Group's voting power has been subsequently reduced as a result of the issuance of EOS shares to persons other than the Northrop Grumman Group, including on 11 October 2019 when its voting power was reduced to below 5% as a result of the issuance of shares to other persons (even though the Northrup Grumman Group continued to hold 5,000,000 EOS shares at the time).
